You will be an integral member of the local health community, working closely with engaged and supportive city and county governments, hospitals, health agencies, police and schools, delivering provincial public health standards, addressing local issues, improving population health and providing advice and reassurance to the public. In response to the COVID-19 pandemic, public communications, testing and Phase 1 vaccinations are in-hand, and critical health unit responsibilities are being maintained.
